Dear Potrero Annex and Terrace Resident:

We are excited to announce that BRIDGE Housing Corporation has been selected by the San Francisco Housing Authority (SFHA) to start the process of rebuilding and revitalizing your two communities. As you may know, SFHA and the Mayor's Office of Housing (MOH) chose your two communities to be revitalized together as one of the first HOPE SF sites. The goal of the HOPE SF program is to revitalize and rebuild public housing sites throughout the City and to transform them into vibrant new communities that provide healthier homes, safer communities, and enhanced and expanded resident and community services.

The revitalization program for the Annex and Terrace will take place in phases over several years and will include the following:

**ONE FOR ONE REPLACEMENT OF THE EXISTING PUBLIC HOUSING (606 UNITS) WITH NEW APARTMENT HOMES;**

**EMPLOYMENT OPPORTUNITIES FOR RESIDENTS DURING THE REBUILDING**

**EXPANDED HOUSING TYPES, SUCH AS HOMEOWNERSHIP AND ADDITIONAL RENTAL HOUSING**

**EXPANDED AND ENHANCED OFF-SITE AND/OR ON-SITE RESIDENT AND COMMUNITY SERVICES**

We expect to hold the first resident meeting in September 2008 to begin the process of developing a plan for the new community. There will be many meetings with both residents and members of the greater community throughout the process. We will notify you of all meetings and strongly encourage you to attend as many as possible. We promise to provide refreshments for every event!

BRIDGE is very committed to working closely with residents and the resident leadership of the Annex and Terrace throughout the development process. You are a critical member of the team and we want you to have your voices heard.
