Details: Cahill contractors will continue working on 25th St. between Dakota & Connecticut as part of the Hope VI Project. This will require the partial closure of 25th St. between Dakota & Connecticut. As a result, Line 10 must reroute as noted below. Please inform your passengers of the reroute and the impact to passenger service. Line 48 must reduce speed and use extra caution on 25th Street in the construction area.

Inbound: via regular route on 26th St to Wisconsin, **continue on Wisconsin** to regular route. Do not use Dakota.
